- Approval of Minutes from January 6, 2016 meeting Moved by: John Rimas and Seconded by: James Vershbow; Unanimously approved.
- 2. Update from Subcommittee on Progress Reports W.MacLaughlin
 - Adam Silverberg, Siran, Linda Tracy to meet and look at the parent feedback to brainstorm a compromise before next progress report and propose to Shirley
 - Shirley will input a smaller list of comments into PowerSchool pending finalization of the report
 - Looking into possibility of custom comments
 - Look into removing watermark on report cards/progress reports the watermark can make it hard to read
- 3. Update from Subcommittee on Parent Conference Night J. Rimas
 - Handout with some responses from parents and summarized teacher feedback
 - Discussion will also take place at the union meeting to see what the contract allows teachers to be able to do, or whether a change might be proposed
